TENDER NOTICE FOR E-PROCUREMENT OF MS RACKS

Online Tender on e-Procurement Portal https://cgmfpfedtenders.abcprocure.com as in Annexure - I (Technical Tender) and Annexure - II (Financial Tender) are invited from eligible tenderers for the supply and installation for MS Racks as per specification given in Section 1 by Chhattisgarh State Minor Forest Produce (Trading & Development) Cooperative Federation Limited.

- 1. Tender notice along with Section 1, Annexure-I, II, III, IV and V giving detailed specification / delivery schedule etc, can be seen and downloaded from Federation's www.cgmfpfed.org e-Procurement website portal and https://cgmfpfedtenders.abcprocure.com only.
- 2. (i) Tenders are to be submitted only online in the prescribed Tender Forms only for Technical Tender (Annexure – I) and Financial Tender (Annexure - II).

(ii) The tenderer will propose in Financial Tender the rate (inclusive of Basic Rate, G.S.T and Other Taxes if any should be mentioned) F.O.R destination including all taxes i.e., Services Tax and surcharge and the Local Bodies Taxes if any on F.O.R destination basis. (Delivery locations (Destination) of all the items as mentioned in clause 4 below is provided in Annexure III.)

- 4. The Tenderer shall submit online Technical and Financial Tender in separate Technical Tender Envelope and Financial Tender Envelope respectively mentioned in Annexure - IV.
- 5. The tenderer should upload certified photocopies of all the documents required in this tender notice. The tender shall be accepted up to 15.00 hrs. on 04.08.2022 and Tender shall be opened online in this office only at 15.10 hrs. on 04.08.2022 even if it is a public holiday by the duly constituted Committee.
- 6. Decision of the Managing Director of the Federation to declare any of the tenderer to have or have not gualified in Technical Tender shall be final and binding on the tenderer. Intimation of decision of the competent authority shall be conveyed to the tenderers.
- 7. Financial Tender of only those tenderers who qualify in the pre-qualification shall be opened.
- 8. Earnest Money Deposit (EMD): The tenderer will have to make the online payment of EMD as shown in Clause 4 of the tender document. EMD amount as shown in Clause 4 of the Tender document will have to be deposited by the tenderer irrespective of the number of MS Racks for which the tenderer is applying the tender for. The tender/s will

summarily be rejected if there is any discrepancy in the amount of EMD that is required to be deposited. EMD has to be deposited through payment gateway service provider in any of the following ways -

- A. Credit Card / Debit Card (VISA / Master / Maestro Cards) The tenderer after selecting the option of the Credit Card / Debit Card (VISA / Master / Maestro Cards) make the online payment, as per the instructions of payment mentioned in the payment gateway.
- B. **Net Banking** Tenderer can make the payment only from the bank account in having net banking facility. The list of banks for net banking will appear in the payment gateway and tenderer should select his bank from that list and make the payment as per the instructions given in the payment gateway.
- C. **RTGS / NEFT** The tenderer can make the payment as per the instructions of clause 2.2 of enclosed **Annexure IV**.

The E.M.D. of unsuccessful tenderers will be returned online only in the Bank Account mentioned in the point no. 13 of Form No. 1 **Annexure – I** only. No interest on E.M.D. will be paid in any circumstances.

- 9. The rate offered by the tenderer in the Financial Tender will be valid up to forty-five days from the date of opening of the Financial Tender but not later than 75 days of opening of the Technical Tender.
- 10. Rate should be clearly mentioned in the Financial Tender in figures only. The tenderer can tender for the item category mentioned in clause 4 of this tender notice and pay the EMD accordingly.

11. Eligibility Criteria

- i. The tenderer should be a Registered Firm.
- ii. The tenderer shall have minimum Annual Turnover of INR 5 lakhs (five lakhs) in anyone
 (1) of the past three (3) years (i.e., FY 2019-20, 2020-21, 2021-22) preceding the Tender Due Date
- iii. The tenderer must have latest GST/VAT/Sales Tax Clearance certificate along with copy of Registration certificate under Sales Tax.
- iv. The tenderer must submit the blacklisting certificate indicated that their firm is not blacklisted from any Government Organization.
- v. As per section 139A of the Income Tax Act, 1961, enclosing of scanned copy of PAN card is compulsory for the tenderer.
- vi. Enclosing of Scanned copy of Aadhaar Card issued by Unique Identification Authority of India. (UIDAI) is compulsory. Scanned copy of Aadhaar Card of Managing Director of the Company and in case of Partnership firm Aadhaar Card of at least two of Partners required, in case of Hindu Undivided Family (HUF) Aadhaar Card of Karta and one adult family member is to be enclosed.

12. Person Authorised to Submit Tender

- i. Person or persons signing the tender form shall state in what capacity he or she or they are signing the tender form e.g. as sole proprietor of the firm concerned or as Managing Director or Director or Secretary of Limited Company. In the case of partnership firm, the names of all the partners should be recorded and the tender form should be signed by all the partners or their duly constituted attorney having authority to bind all partners in all matters pertaining to the contract as recorded in the power of attorney or in the partnership deed. True copy of the Registered "Partnership Deed" should be uploaded along with the tender form failing which the tender shall be liable to be rejected. It shall be obligatory on the part of every partner of the firm, which enters into agreement to fulfil the terms and conditions of the agreement during the currency of the contract thereof, notwithstanding the dissolution of the partnership in the meantime. In the case of a limited company, the tender form shall be signed by a person empowered to do so by the company, copy of Certificate of incorporation of the company and the letter authorizing the person signing the tender documents shall be uploaded to the tender form failing which the tender shall be liable to be rejected. In the case of Hindu undivided family, the names of the family members should be uploaded with the tender form and 'Karta' who can bind the family should sign the tender form.
- ii. The person signing the tender form on behalf of another or on behalf of a Firm shall enclose with the tender form power of attorney or deed duly executed in his favour or the partnership deed giving him such power showing that, he has the authority to bind such other person or the firm, as the case may be in all matters pertaining to the contract. If the person so signing the tender form fails to upload the said power of attorney or partnership deed, his tender shall be liable for summary rejection. The power of attorney should be signed by all the partners in the case of partnership concerns, by the proprietor in case of a proprietary concern and by the person who by his signature can bind company in the case of limited company. In the case of Hindu undivided family, the power of attorney should be signed by the 'Karta' who by his signature can bind the family.

- 13. The tenders submitted online should be signed electronically with a Digital Certificate to establish the identity of the tenderer tendering online. The tenderer can obtain the Digital Signature Certificate as per the instructions of step 1 of clause 1 of enclosed Annexure IV.
- 14. In order to participate in the tender, the tenderer is required to get registered on the e-Procurement portal (https://cgmfpfedtenders.abcprocure.com). Only after online registration of the tenderer, the tenderer shall be allowed to participate in the tenders floated by the C.G.M.F.P Federation using the e-Procurement System. After obtaining the Digital Certificate as mentioned in above S.No. 14 and successfully installed on their system, the tenderer has to be online registered through "New Tenderer Registration" page of the e-Procurement portal (https://cgmfpfedtenders.abcprocure.com) and mapped their Digital Certificate.
- 15. The Instructions for submission of online tender (Annexure IV) for tenderers to submit the online tenders will be available on e-Procurement portal https://cgmfpfedtenders.abcprocure.com and the online tender can be submitted as per time and date mentioned in time schedule (Annexure - V).
- 16. The tenderers will have to submit (Upload Scan Copies / fill) his / her offer / credentials online as required in the tender in the online templates in relevant envelopes.
- 17. The tenderers may refer User Manual for tenderers available online to perform their online activities. (Annexure IV)
- 18. The Managing Director, Chhattisgarh State Minor Forest Produce (Trading & Development) Co-operative Federation Limited reserves the right to accept / reject any or all the tenders without specifying any reason thereof. He may relax any tender condition.
- 19. Conditional offer other than on our terms and conditions shall not be accepted.
- 20. SUPPLIERS WHO MAY NOT BE IN A POSITION TO MAKE TIMELY SUPPLIES OF QUALITY MS RACKS ACCORDING TO TENDER SPECIFICATION AND GOOD FINISH SHOULD NOT TENDER.
- 21. Tenderers who are selected after opening of the financial tender have to supply the MS Racks within 15 days of release of sanction letter.
- 22. For the interpretation of the tender conditions, the decision of the Managing Director of Chhattisgarh State M.F.P Federation will be final. In case of any clarification, the tenderer may contact the Managing Director, Chhattisgarh State Minor Forest Produce (Trading & Development) Co-operative Federation Limited, Raipur.
- 23. All the terms & conditions of this tender notice will be binding on the supplier / tenderer.
- 24. The amendments in this tender notice are possible. The amendments will be available on Federation's website www.cgmfpfed.org and e-Procurement portal https://cgmfpfedtenders.abcprocure.com. only. The tenderer should regularly view the above website and portal till the opening of financial tender so that he can take the appropriate action according to the amendments.






- 1. Providing, Fixing, Fabricating and Installation of MS Rack (Size 2.5m x 1.5 m x 4.2m) with detachable shelf system.
- 2. Shelf System Comprising of MS Post of MS angle section 25x25x5 mm bolted together with the detachable shelfs.
- 3. Shelf made-up of MS angle section 25x25x5mm & MS square bar 25mm diameter welded (Welding specification as per CGPWD SOR 2015) together as per the drawing.
- 4. For MS angle 90-degree joints use mitred joints.
- 5. Complete Rack coated with hot-dip zinc coating as per IS 4759 : 1996 standard.
- 6. For Fabrication & Fixing detailed drawings are to be referred.






MS RACK PLAN

TENDER NOTICE FOR E-PROCUREMENT OF MS RACKS

- The supplier / tenderer shall be deemed to have carefully examined the terms and conditions, specifications, etc. of the MS Racks to be supplied. If he has any doubt as to the meaning of any portion of the conditions, specifications he may, refer to the Managing Director, Chhattisgarh State Minor Forest Produce (T & D) Co-operative Federation Ltd., and get clarification.
- 2. The supplier / tenderer shall not assign or sub-let his contract or any substantial part thereof to any other agency without the approval of Managing Director, Chhattisgarh State Minor Forest Produce (T & D) Co-operative Federation Ltd.
- 3. All the stocks supplied shall be of best quality and conform to the specifications. The decision of the Managing Director, Chhattisgarh State Minor Forest Produce (T & D) Co-operative Federation Ltd. shall be binding upon the supplier and in case of any article supplied is not being approved, then expenses or loss caused to M.F.P. Federation as a result of rejection or replacement of supplies, shall be entirely to the account of the supplier.
- 4. The Managing Director, Chhattisgarh State Minor Forest Produce (T & D) Co-operative Federation Ltd. or his duly authorized representative shall at all reasonable time access and examine the materials and workmanship of the MS Racks.
- 5. In case MS Racks other than of the approved quality, make or size are supplied, the same shall have to be replaced immediately by the supplier without extra cost. Any expenses or loss caused to M.F.P. Federation on whose behalf purchase has been made, shall be in account of the supplier.
- 6. The supplier should ensure that the MS Racks are inspected to ascertain the quality material primarily. At the time of loading, the supplier should ensure that the packaging bubble wrap and seals are intact on all the equipment. The MS Racks will be inspected by the person authorized by CGMFPFED at the time of delivery and if the MS Racks are not found in conformity with the given specification / approved quality, make or size as per the Technical specifications provided in Section 1 of the Tender document, the same will be rejected and the supplier shall have to replace the same immediately without any extra cost. Any expenses incurred / loss suffered by CGMFP Federation on this a/c shall be debited to the supplier's a/c.

CGMFPFED can also conduct a joint inspection if required and in case joint inspection is not carried out along with the surveyor within the given time, it would be presumed that the complaints made by the consignees are quite genuine and loss sustained by the consignees, shall be recovered from the supplier.

- **7.** The CGMFP has the right to have a demonstration of the equipment/item in his premises. The supplier has to abide by this condition. The demonstration has to be arranged by the supplier at his own cost.
- 8. The rejected MS Racks must be removed by the supplier from the destination wherever they may be, within fifteen days of the date of inspection. The Purchaser concerned will take care of such materials but in case of delay the purchaser shall not be responsible for any loss, shortage, damage, etc. If the supplier fails to lift the materials within the above prescribed period, extra storage charges will be recovered at the rate of five paise per bag per day.
- **9.** The supplier shall be responsible for the proper standard packing so as to avoid damage under normal conditions of transport by road and shall ensure delivery of the materials in good condition to the consignee at respective centre. In the event of any loss, damage, torn / cut or any shortage found on checking / inspection of the materials by the consignee, the same shall be debited to the supplier's account.
- **10.** The Proposed **rate (inclusive of Basic Rate, G.S.T and Other Taxes if any should be mentioned)** and will be valid up to 45 days from the date of opening of Technical Tender.
- **11.** The Managing Director Chhattisgarh MFP Federation can repudiate the contract of supply at any time, at the risk and cost of the supplier, if the supplies are not made up to satisfaction of CG State MFP (T&D) Co-op. Federation.
- 12. The successful tenderer will have to submit a Performance security of equivalent to 3% of the Contract /Order value before the issue of award letter valid till 60 days beyond the period of expiry of the Warranty/ Guarantee period in shape of crossed Demand Draft/Pay order/Fixed Deposit Receipt/Bank Guarantee from a commercial bank in favour of the CGMFP Raipur, payable at Raipur. The performance security will remain valid till expiry of warranty period. This will be released beyond 60 days after completion of warranty period. - **33.** Laws Governing the Contracts: The contracts shall be governed by the laws of India for the time being in force. The contract shall be interpreted in accordance with these laws.
- **34. Termination of Contracts:** Time shall be the essence of the contract. The purchaser shall have the right to terminate the contract without any notice in part or in full in any of the following cases:

Instructions for the Submission of the Online Tender

Note: The following steps need to be carried out for online submission of the Tender. Detailed instructions for each of the steps are given in the Tenderer's Manual on the Home Page of https://cgmfpfedtenders.abcprocure.com

1. Sequence of steps for online tender submission:

Step 1 – To obtain Digital Signature Certificate (DSC) :

The DSC is issued by an approved certifying authority, authorized by the Controller of Certifying Authorities (CCA), Government of India. The individual may obtain information required for issuance of a Class II / Class III DSC from the Controller of Certifying Authorities (<u>www.cca.gov.in</u>). The tenderer will have to obtain DSC from **https://cgmfpfedtenders.abcprocure.com** or any other CCA approved agency.

DSC is issued upon receipt of mandatory identity proofs and verification letters attested by a Gazetted Officer. Only upon the receipt of the required documents, a DSC can be issued.
