SCOPE OF WORK, DRAWINGS AND SPECIFICATIONS

1. Scope of Work

- 1.1 The scope of work includes Design, Proof Check, Vetting and Approval by any NIT/IIT Institution, Manufacturing, Testing of Materials by Approved Agency, Transportation of Approved Material and Installation of PEB as per attached **Annexure A**.
