TENDER NOTICE FOR E-PROCUREMENT OF MEDICINAL HERBAL PLANTS / SEEDS

1. Online Tender on e-Procurement Portal <https://cgmfpfed.abcprocure.com> as in **Annexure – I (Technical Bid) and Annexure - II (Financial Bid)** are invited only from eligible bidders i.e., **Owner of Plant Nursery for the supply of Medicinal Herbal Plants/Seeds as per specification given in Section 1** by Chhattisgarh State Minor Forest Produce (Trading & Development) Cooperative Federation Limited.
2. Tender notice along with **Section 1, Annexure-I, II, III, IV, V and VI** giving detailed specification / delivery schedule etc, can be seen and downloaded from Federation's website www.cgmfpfed.org and e-Procurement portal <https://cgmfpfedtenders.abcprocure.com> only, on the following Dates:-

3. (i) Tenders are to be submitted only online in the prescribed Tender Forms only for **Technical Bid (Annexure – I) and Financial Bid (Annexure - II)**.

(ii) The tenderer will propose in Financial Bid the **rate (inclusive of Basic Rate, G.S.T and Other Taxes if any should be mentioned)** F.O.R destination including all taxes i.e., Goods and Services Tax and surcharge and the Local Bodies Taxes if any on F.O.R destination basis. (Delivery locations (Destination) of all the items as mentioned in clause 4 (Table 1 and Table 2) below is provided in Annexure IV.

5. The Tenderer shall submit online Technical and Financial Bid in separate Technical Bid Envelope and Financial Bid Envelope respectively mentioned in **Annexure - V**.
6. The tenderer should upload certified photocopies of all the documents required in this tender notice. The tenders shall be accepted up to **15.00 hrs. on 31.05.2023** and Bid shall be opened online in this office only at **15.10 hrs. on 31.05.2023** even if it is a public holiday by the duly constituted Committee.
7. Decision of the Managing Director of the Federation to declare any of the tenderer to have or have not qualified in Technical Bid shall be final and binding on the tenderer. Intimation of decision of the competent authority shall be conveyed to the tenderers.
8. Financial Bid of only those tenderers who qualify in the pre-qualification (Eligibility Criteria) shall be opened. Financial Bid of only those tenderers who qualify in the pre-qualification (Eligibility Criteria) shall be opened and Financial bid of only those tenderers will be considered whose sample(s) is/are conforming to the Technical specifications provided by the Federation in Section 1 and has been approved by the technical committee constituted for the purpose. **Samples for each item that the bidder has applied for should reach Federation on or before the last date of submission of Bid as mentioned in clause 6 above or any extension provided by Federation. Bids for which the Samples has not reach Federation on or before the last date of submission of Bid shall be summarily rejected.**
9. Earnest Money Deposit (EMD): The tenderer will have to make the online payment of total amount of EMD as shown in **Clause 4 (Table 1 and Table 2)** of the tender notice. If the tenderer is applying the tender for the supply of one Item or multiple items mentioned in **clause 4:Table 1**, EMD amount pertaining to that particular **Table 1** will have to be deposited by the tenderer. In case where the tenderer is applying for one or more items/mentioned under Table 1 and Table 2 both, then the total EMD amount which will be equivalent to the sum of EMD amount mentioned in table 1 as well as Table 2 will have to be paid. **Illustration: In case of application for supply of four items, two items from table 1 and two items of Table 2 then the bidder will have to pay total EMD amount i.e., Table 1 – INR 35,000 and Table 2- INR 35000.00= INR 70,000/-, will have to be deposited by the Tenderer.** The bid/s will summarily be rejected if there is any discrepancy in the amount of EMD that is required to be deposited. **For example: If tenderer has applied bid for 3 (three) items; two items Clause 4:Table 1 and one item clause 4:Table 2 but has deposited the EMD amount mentioned in Table 1 (i.e., INR 35,000/-), then the bid shall be considered for evaluation of items specified under Clause 4: Table 1 (Medicinal Herbal Plant) only and the bid submitted for Table 2 (Medicinal herbal plant Seed) shall not be evaluated. EMD has to be deposited through payment gateway service provider in any of the following ways -**
 1. **Credit Card / Debit Card (VISA / Master / Maestro Cards)** - The tenderer after selecting the option of the Credit Card / Debit Card (VISA / Master / Maestro Cards)

make the online payment, as per the instructions of payment mentioned in the payment gateway.

2. **Net Banking** - Tenderer can make the payment only from the bank account in having net banking facility. The list of banks for net banking will appear in the payment gateway and tenderer should select his bank from that list and make the payment as per the instructions given in the payment gateway.
3. **RTGS / NEFT** - The tenderer can make the payment as per the instructions of clause 2.2 of enclosed **Annexure - V**.

The E.M.D. of unsuccessful tenderers will be returned online only in the Bank Account mentioned in the point no. 13 of Form No. 1 **Annexure – I** only. No interest on E.M.D. will be paid in any circumstances.

9.1 Earnest Money Deposit will be forfeited in following conditions:

- i. If at any stage any information / Declaration given by the Bidder is found False or misleading
- ii. If a bidder withdraws bid during the period of validity specified in the Tender's Terms & Conditions
- iii. In case of any lapse /default in honouring the Terms and Conditions at any stage after submitting the E-Tender
- iv. In case of Final selection of bidder, if bidder fails to furnish contract performance security in accordance with the terms and conditions of the e-tender

10. The rate offered by the tenderer in the Financial Bid will be valid up to forty-five days from the date of opening of the Financial Bid but not later than 75 days of opening of the Technical Bid.

11. Rate should be clearly mentioned in the Financial Bid in figures only. **The tenderer can bid for one / more than one / all the Medicinal Plants/Seeds mentioned in clause 4 (Table 1&Table 2) and clause 9 of this tender notice and pay the EMD accordingly.**

12. **Eligibility Criteria**

- A. The Bidder should be either registered under Companies act or a firm registered under partnership firm, or a cooperative firm registered under cooperative act or a proprietorship firm for at least 3 years. A certificate to this effect should be uploaded.
- B. The Bidder should be the owner of Nursery of quality planting material (Relevant document should be uploaded)
- C. The bidder experience in executing any sizeable work orders of supply of Medicinal herbal Plants/seeds during last 3 year in any Government /Semi Govt., private sector (Work order and completion certificate from client to be uploaded)
- D. Bidder must have a Minimum Annual Average turnover not less INR 10 Lakh from the Supply of Medicinal Herbal Plant/Seed for the last three Financial Years (FY 2018-19, FY 2019-20, FY 2021-2022) (**Scanned copies of Profit and loss statement and Balance Sheets certified by Chartered Accountant having UDIN number, of the last three financial years and Annual Turnover Certificate for last three Financial Years, certified by CA must be uploaded**)
- E. Bidder should be a self-producer of item (s) bidder is quoting for (Bidder has to upload self-declaration in this regard)
- F. The tenderer must submit the blacklisting certificate indicated that their firm is not blacklisted from any Government Organization.

- G.** Samples required to be submitted as per clause 8 of the Tender Notice. Bids for whom the sample has not reached Federation on or before last date of submission of Bid shall be summarily rejected.

Documents to be enclosed (Mandatory)

- I. The tenderer must have latest GST/VAT/Sales Registration certificate.
- II. As per section 139A of the Income Tax Act, 1961, enclosing of scanned copy of PAN card is compulsory for the tenderer.
- III. Enclosing of Scanned copy of Aadhaar Card issued by Unique Identification Authority of India. (UIDAI) is compulsory. Scanned copy of Aadhaar Card of Managing Director of the Company and in case of Partnership firm Aadhaar Card of at least two of Partners required, in case of Hindu Undivided Family (HUF) Aadhaar Card of Karta and one adult family member is to be enclosed.
- IV. The bidder should compulsorily disclose the number of Medicinal herbal Plants/Seeds, variety, Height, area under plantation of the Medicinal herbal Plant/Seed bidder is applying for and total area of nursery available for plantation of Medicinal herbal Plant/seed etc. with technical bid along with annual production of the nursery and number of ready to supply item(s) for which bidder is bidding while submission of the Technical Bid. (Written declarations on the letter head of the bidder on above heads should be uploaded)

13. Person Authorised to Submit Bid

- (i) Person or persons signing the tender form shall state in what capacity he or she or they are signing the tender form e.g., as sole proprietor of the firm concerned or as Managing Director or Director or Secretary of Limited Company. In the case of partnership firm, the names of all the partners should be recorded and the tender form should be signed by all the partners or their duly constituted attorney having authority to bind all partners in all matters pertaining to the contract as recorded in the power of attorney or in the partnership deed. True copy of the Registered "Partnership Deed" should be uploaded along with the tender form failing which the tender shall be liable to be rejected. It shall be obligatory on the part of every partner of the firm, which enters into agreement to fulfil the terms and conditions of the agreement during the currency of the contract thereof, not with standing the dissolution of the partnership in the meantime, In the case of a limited company, the tender form shall be signed by a person empowered to do so by the company, copy of Certificate of incorporation of the company and the letter authorizing the person signing the tender documents shall be uploaded to the tender form failing which the tender shall be liable to be rejected. In the case of Hindu undivided family, the names of the family members should be uploaded with the tender form and 'Karta' who can bind the family should sign the tender form.
- (ii) The person signing the tender form on behalf of another or on behalf of a Firm shall enclose with the tender form power of attorney or deed duly executed in his favour or the partnership deed giving him such power showing that, he has the authority to bind such other person or the firm, as the case may be in all matters pertaining to the contract. If the person so signing the tender form fails to upload the said power of attorney or partnership deed, his tender shall be liable for summary rejection. The power of attorney should be signed by all the partners in the case of partnership concerns, by the proprietor in case of a proprietary concern and by the person who by his signature can bind company in the case of limited company. In the case of Hindu undivided family, the power of attorney should be signed by the 'Karta' who by his signature can bind the family.

- 14.** A bidder shall not have conflict of interest. All bidders found to have conflict of interest

shall be disqualified. A bidder may be considered to be in conflict of interest with one or more parties in this bidding process, if, including but not limited to:

- a) They have controlling shareholders in common or
 - b) They receive or have received direct or indirect subsidy from any of them or
 - c) They have the same legal representative for purposes of this bid or
 - d) They have a relationship with each other, directly or through common third parties,
 - e) that puts them in a position to have access to information about or influence on the bid of another bidder or
 - f) A bidder participates in more than one bid in this bidding process. Participation by a bidder in more than one bid will result in the disqualification of all bids in which the party is involved.
 - g) A bidder participated as a consultant in the preparation of the design or technical specification of the contract that is subject of the bid
15. The successful bidder will have to submit a Performance security of equivalent to 3% of the Contract /Order value before the issue of award letter valid till 6 months beyond the period of defect liability of 6 months in shape of crossed Demand Draft/Pay order/Fixed Deposit Receipt/Bank Guarantee from a commercial bank in favor of the CGMFP Raipur, payable at Raipur. This will be released beyond 6 months after completion of 6 Months Defect Liability Period. If the security deposit is not deposited within the specified time, the supply order will be cancelled, the EMD will be forfeited and the tenderer may be blacklisted for future transactions with Federation by the Managing Director Chhattisgarh MFP Federation, Raipur for a maximum period of 3 years. No interest shall be paid by CG State MFP (T&D) Co-op. Federation on such security deposit.
16. The bids submitted online should be signed electronically with a Digital Certificate to establish the identity of the tenderer tendering online. The tenderer can obtain the Digital Signature Certificate as per the instructions of step 1 of clause 1 of enclosed Annexure - V.
17. Representatives authorised by Federation shall visit the Nursery prior to opening of Financial bids and if any irregularities are found during the visit Federation reserves the right to reject the tender.
18. In order to participate in the tender, the tenderer is required to get registered on the e-Procurement portal (<https://cgmfpfed.abcprocure.com>). Only after online registration of the tenderer, the tenderer shall be allowed to participate in the tenders floated by the C.G.M.F.P Federation using the e-Procurement System. After obtaining the Digital Certificate as mentioned in above S.No. 15 and successfully installed on their system, the tenderer have to be online registered through “New Bidder Registration” page of the e-Procurement portal (<https://cgmfpfed.abcprocure.com>) and mapped their Digital Certificate.
19. The Instructions for submission of online tender (Annexure - V) for tenderers to submit the online tenders will be available on e-Procurement portal <https://cgmfpfed.abcprocure.com> and the online tender can be submitted as per time and date mentioned in time schedule (Annexure - VI).
20. The tenderers will have to submit (Upload Scan Copies / fill) his / her offer / credentials online as required in the tender in the online templates in relevant envelopes.
21. The tenderers may refer User Manual for tenderers available online to perform their online activities. (Annexure V)
22. The Managing Director, Chhattisgarh State Minor Forest Produce (Trading & Development) Co-operative Federation Limited does not bind itself to accept the lowest or any other tender

and reserves the right to accept / reject any or all the tenders without specifying any reason thereof. CGMFPFED reserves the right to relax any tender condition.

23. Conditional offer other than on our terms and conditions shall not be accepted.
24. SUPPLIERS WHO MAY NOT BE IN A POSITION TO MAKE TIMELY SUPPLIES OF QUALITY MATERIAL ACCORDING TO TENDER SPECIFICATION AND GOOD FINISH SHOULD NOT BID.
25. Tenderers who are selected after opening of the financial bid have to supply the equipment/ items/ goods within 15 days of release of sanction letter.
26. For the interpretation of the tender conditions, the decision of the Managing Director of Chhattisgarh State M.F.P Federation will be final. In case of any clarification, the tenderer may contact the Managing Director, Chhattisgarh State Minor Forest Produce (Trading & Development) Co-operative Federation Limited, Raipur.
27. All the terms & conditions of this tender notice will be binding on the supplier / tenderer.

The tenderer should regularly view the above website and portal till the opening of financial bid so that he can take the appropriate action according to the amendments.

**TERMS AND CONDITIONS FOR THE SUPPLY OF MEDICINAL HERBAL PLANTS
/ SEEDS**

1. The supplier / tenderer shall be deemed to have carefully examined the terms and conditions, specifications, etc. of the goods to be supplied. If he has any doubt as to the meaning of any portion of the conditions, specifications he may, refer to the Managing Director, Chhattisgarh State Minor Forest Produce (T & D) Co-operative Federation Ltd., and get clarification.
2. The supplier / tenderer shall not assign or sub-let his contract or any substantial part thereof to any other agency/contractor
3. All the medicinal herbal plants/seeds supplied shall be of best quality (i.e., Healthy and in good condition) and should conform to the specifications as per tender document. The decision of the Managing Director, Chhattisgarh State Minor Forest Produce (T & D) Co-operative Federation Ltd. shall be binding upon the supplier and in case of any item supplied is not being approved, then expenses or loss caused to M.F.P. Federation as a result of rejection or replacement of supplies, shall be entirely to the account of the supplier.
4. The Managing Director, Chhattisgarh State Minor Forest Produce (T & D) Co-operative Federation Ltd. or his duly authorized representative shall at all reasonable time access and examine the quality of supplied Medicinal herbal Plants and Seeds.
5. In case Medicinal Herbal Plants and Seeds other than of the approved specifications, quality, or size etc. are supplied, the same shall have to be replaced immediately by the supplier without extra cost. Any expenses or loss caused to M.F.P. Federation on whose behalf purchase has been made, shall be on account of the supplier.
6. The supplier should ensure that the goods/items (Medicinal herbal Plants and Seeds) are inspected and approved by the Inspection Agency or representative authorized by Federation to ascertain the quality material primarily. At the time of loading and unloading, the supplier should ensure that the Plants/Seeds are intact and not damaged. The supplier shall be responsible for unloading the Medicinal Plants/Seed at the delivery location. The inspection and sealing charges of inspection agency will be borne by CGMFPFED. If in the inspection, the supplied Medicinal Herbal Plants and Seeds are not found in conformity with the given specification / required quality, or size as per the Technical Specifications as per Section 1 (Table 1 and Table 2) of the Tender Document, the same will be rejected and the supplier shall have to replace the same immediately without any extra cost. Any expenses incurred / loss suffered by CGMFP Federation on this a/c shall be debited to the supplier's a/c.

CGMFPFED can also conduct a joint inspection if required and in case joint inspection is not carried out along with the supplier within the given time, it would be presumed that the complaints made by the consignees are quite genuine and loss sustained by the consignees, shall be recovered from the supplier.

7. The rejected Plants/Seeds must be removed by the supplier from the destination wherever they may be, within fifteen days of the date of inspection. The Purchaser concerned will take care of such rejected Plants/Seeds but in case of delay the purchaser shall not be responsible for any loss, shortage, damage, etc.
8. The supplier shall be responsible for the proper standard packing so as to avoid damage under normal conditions of transport by road and shall ensure delivery of the materials/items (i.e., Medicinal herbal Plants and Seeds) in good condition to the consignee at respective centers (Delivery locations). In the event of any loss, damage, torn / cut or any shortage found on checking / inspection of the materials/items by the consignee, the same shall be debited to the supplier's account.
9. The Proposed **rate (inclusive of Basic Rate, G.S.T and Other Taxes if any should be mentioned)** and will be valid up to 45 days from the date of opening of Technical Bid.

37. Any dispute arising in connection with this agreement not amicably settled, would be referred to the arbitrator i.e., three-member Committee appointed by Chhattisgarh Govt. Raipur who will act as sole arbitrator and the verdict of the arbitrator shall be final and binding on both the parties.
38. The Chhattisgarh State Minor Forest Produce (T & D) Co-operative Federation Ltd. shall have the right to accept or reject any or all tenders without assigning any reason thereof.
39. Allocation of quantity / destinations to any tenderer shall be at the sole discretion of the Managing Director, Chhattisgarh State Minor Forest Produce (T & D) Co-operative Federation Ltd. The proposed supply work may be increased as per need of this office

1. Sequence of steps for online tender submission:

Step 1 – To obtain Digital Signature Certificate (DSC):

The DSC is issued by an approved certifying authority, authorized by the Controller of Certifying Authorities (CCA), Government of India.
