## Guidelines and Conditions related to online Tender Process

1. Tenderers participating in e-tendering for the first time should complete the formalities like registration, digital signature etc. in advance before filling the tender.
2. Tenderers willing to participate in the tender are required to first register themselves on the portal <https://cgmpfed.abcprocure.com> & after completing the process, he will be able to participate in the tender process.
3. (i) The Technical Bid Form (**Annexure-1 Form 1, 2, 3 & 4**) & Financial Bid Form (**Annexure-2 Form 1 & 2**) can be downloaded from the Federation's website or online portal as shown above.  
(ii) The tenderer will propose in Financial Tender the rate (inclusive of Basic Rate, G.S.T and Other Taxes if any should be mentioned) F.O.R destination including all taxes i.e., Tetra Pack (6 Layer Laminate) Packaging Material and Services Tax and surcharge and the Local Bodies Taxes if any on F.O.R destination basis. 6. Registered firms in the business of supplying packaging material for food products are eligible to participate in this tender
7. **Earnest Money Deposit (EMD)** - The Tenderer will have to deposit the Earnest Money Deposit (EMD) of Rs.10,000/-, which will be required to be deposited by e-payment through online portal. The Earnest Money Deposit (EMD) will not be accepted in any other form & no interest will be payable on the Earnest Money Deposit (EMD).
8. 9. Tenderers will have to regularly visit the website of the Minor Forest Produce Association [www.cgmpfed.org](http://www.cgmpfed.org) and the portal <https://cgmpfedtenders.abcprocure.com> for clarification related to the tender or the extension of the due date.
10. Tender is non-transferable. Tender will be rejected without the amount of Earnest Money Deposit (EMD).
11. Tenderer must submit e-tender with digital signature. For this, the tenderer will have to register online on the portal <https://cgmpfedtenders.abcprocure.com>. Tenderers can obtain the digital certificate from an organization approved by the CCA. Tenderers who already have a valid digital certificate need not get a new digital certificate.
12. Conditional bid will not be accepted.
13. The e-tender bid will contain 2 electronic envelopes: -
  - (1) Technical Bid
  - (2) Financial Bid
14. Scanned copies of required documents which are self-attested by the authorized person will have to be uploaded in the technical bid envelope.
15. Eligibility Criteria  
Registered firms in the business of supplying packaging material for food products are eligible to participate in this tender
  - I) **Technical Capacity**
    - i. Applicant firm must has supplied tetra pack (6 Layer Laminate) package material worth at least INR 8 lakhs in the past three years; **Or**
    - ii. Applicant firm must has supplied any other package material worth at least INR 12 lakhs in the past three years
  - II) **Financial Capacity**
    - i. The minimum annual Average turnover of INR 5 Lakhs for the last 3 years (FY 2019-20, FY 2020-21, FY 2021-22); **Or**
    - ii. The minimum annual Average turnover of INR 10 Lakhs for the last 3 years (FY 2019-20, FY 2020-21, FY 2021-22)
16. While filling the online financial bid, the tenderer should ensure that the technical evaluation has been done by the tenderer as per specification mentioned in **Annexure-5** and is capable of and can provide the desired material.
17. While filling the online financial bid, the tenderer should ensure that the specification of material mentioned in **Annexure-5** of the e-tender is capable of being supplied within the stipulated time limit. Partial tender will not be accepted.

18. If the supplied material is not found to be of the prescribed standards and of optimum quality, the tenderer will replace the same at his own cost. The tenderers are suggested to take action to fill the e-tender after seeing the indicative sample of the products present in the Federation headquarters from 10:00 am to 5:00 pm on the official days before filling the tender.
19. In case of non-compliance with the standard, action will be taken as per rules.
20. Tender forms can be submitted in electronic format on the portal of Minor Forest Produce Federation <https://cgmfpfedtenders.abcprocure.com> by the time and date mentioned in the online advertisement. Technical and Financial bids are to be submitted online only and not to be submitted physically.
21. **TECHNICAL BID -**  
(The following documents are mentioned at point number 20.1 to 20.12 along with the tender form and it is mandatory to upload the scanned documents in the online technical bid, failing to which, the tender will be rejected).
  - 20.1 Details of tender Earnest Money Deposit (EMD) amount deposited by e-payment.

- 20.12 Authorization letter on the letterhead of the institution for participation in the tender by the institution
22. If the date of opening of the tender remains a holiday for any reason, then action will be taken to open the tenders at the scheduled time on the next working day, which will be informed online.
23. All the bid sheets related to the tender will be submitted online.
24. In case all the tenders cannot be opened due to any reason on the date of opening of the tender, the work of opening the remaining tenders will continue the next working day.
25. The financial bids of only the successful tenderers in the technical bid will be opened. The samples received from the tenderers who are found technically eligible will be tested. The list of tenderers whose samples are found suitable will be uploaded on the website of the Minor Forest Produce Federation. Only the financial proposal of the item related to the sample found suitable will be considered.
26. This Institute will not be responsible for delay or non-receipt of tender form.
27. Tender sent by fax or e-mail will not be accepted.
28. **Financial Bid -**
- 28.1 Tenderers will be able to submit their rates for the Packaging Material as specified in **Annexure-5** through online mode only in the prescribed column. Financial tender in physical form will not be accepted. Partial tender will not be accepted.
- 28.2 Rates of the product should be submitted per nos. as mentioned in the tender. The tenderer will propose in Financial Tender the rate (inclusive of Basic Rate, G.S.T and Other Taxes if any should be mentioned) F.O.R destination including all taxes i.e., for supply of Tetra Pack (6 Layer Laminate) Packaging Material and Services Tax and surcharge and the Local Bodies Taxes if any on F.O.R destination basis.
- 28.3 The rates of the product shall be inclusive of insurance, delivery, transportation and unloading of goods to the centers located in **Annexure-9**. The rates offered will be valid in the prescribed format only.
- 28.4 The Proposed rate (inclusive of Basic Rate, G.S.T and Other Taxes if any should be mentioned) and will be valid up to 45 days from the date of opening of Financial Tender but not later than 75 days of the opening of the Technical Tender.
- 28.5 **Negotiation-** In case the minimum rates received are more than the market rates, the **Managing Director** will have the right to negotiate on the rates and quality with the successful tenderer.
- 28.6 If due to any reason the agreement is not executed by the lowest tenderer within the stipulated period, then the Managing Director will have the right to propose the offer to the second tenderer at the lowest rates, and third, fourth respectively

to provide material if the last lowest tenderer rejects the offer. In such case the security deposit of the successful first tenderer will be forfeited.

29. Right to Reject the tender - Managing Director, Chhattisgarh State Minor Forest Produce Federation will have the right to reject any part or whole of the tender without assigning any reason.
30. It is expected from the tenderer that the price or rates of different items indicated in the tender form shall be indicated separately. According to the number shown in the tender, based on the total value of all the items, the amount of the lowest tender will be considered successful in the financial bid.
31. A bidder shall not have conflict of interest. All bidders found to have conflict of interest shall be disqualified. A bidder may be considered to be in conflict of interest with one or more parties in this bidding process, if, including but not limited to:
  - a) They have controlling shareholders in common or
  - b) They receive or have received direct or indirect subsidy from any of them or
  - c) They have the same legal representative for purposes of this bid or
  - d) They have a relationship with each other, directly or through common third parties, that puts them in a position to have access to information about or influence on the bid of another bidder or
  - e) A bidder participates in more than one bid in this bidding process. Participation by a bidder in more than one bid will result in the disqualification of all bids in which the party is involved.
  - f) A bidder participated as a consultant in the preparation of the design or technical specification of the contract that is subject of the bid
32. **Security Deposit-** According to the C.G. Stores Purchase Rules and Service Procurement Rules, 2015, the successful tenderer will have to deposit the performance Bank Guarantee amount in the form of security deposit to ensure proper execution of the tender. Before signing the agreement to the successful tenderer, 3% of contract value as security deposit by demand draft/term deposit receipt/banker's check in favor of “**MD MFP Fed Raipur**” from any commercial bank Payable at Raipur or Bank Guarantee valid for 18 months in favor of “**MD MFP Fed Raipur**”. The Amount of Security Deposit will be refunded separately after acceptance of next tender.
33. Only on receipt of Security Deposit from the successful tenderer, the Earnest Money Deposit (EMD) deposited online on the portal by the tenderer will be returned to his account as per the condition of online portal.
34. Agreement of the Tenderer - An agreement by the successful tenderer on a non-judicial/notarized stamp letter of Rs.100/- (to be borne by the tenderer) with the "Managing Director Chhattisgarh State Minor Forest Produce Federation". This must be done within 10 days of intimation.
35. **Condition of Supply -**
  - 35.1 The successful tenderer will be informed in writing and the artwork to be printed on the packaging material shall be provided by the Federation to the successful tenderer.

- 35.2 The quantity bifurcation of the Packaging material variant wise will be decided mutually after the selection of Successful Tenderer.
- 35.3 The tenderer will be informed by the federation or its authorized representative about when, what quantity and where the product is to be supplied. The supply is to be done to the delivery location /destination shown in **Annexure-9**.
- 35.4 The “Managing Director, Chhattisgarh State Minor Forest Produce Federation” will have the right to increase or decrease the quantity of products by 20 percent & size by 10 percent as per details mentioned in Annexure-5.
- 35.5 After the supply order issued to the supplier, if the supply is not done within the prescribed time (minimum period of supply of material in the supply order will be 15 working days), then the "Managing Director Chhattisgarh State Minor Forest Produce Federation" will have the right to He should deduct 1% of the value of the total supply as penalty per week.
- 35.6 Suppliers should ensure that only the prescribed standards and high-quality materials are supplied. The material to be supplied will be subjected to technical specification test as per the specifications of the tender, as well as Certification of Analysis (COA) along with certification of Food grade material, need to be submitted with the supply.
- 35.7 At the time of receipt of the product/material sent by the tenderer, the responsibility of the tenderer will be for any loss or damage to the quantity. The Chhattisgarh State Minor Forest Produce Federation will not be responsible for the receipt of the product for which the supply order has not been issued.
- 36.** Inspection can be done by the Managing Director of the State Minor Forest Produce Federation or any representative of the Chhattisgarh State Minor Forest Produce Association, of the offices & godown of the successful tenderer.
- 37.** No product can be supplied by the tenderer through sublet.
- 38.** In the event of non-supply of the mentioned materials by the successful tenderer on time and in the prescribed quantity, it will be purchased directly from the market and if there is any difference in the price of the purchased material, then the amount of difference will be recovered from the successful tenderer. In such a situation, the performance security deposit may be acquired, deposited by the tenderer as security deposit.
- 39. Payment -**
- Payment term shall be decided mutually between Federation and successful Tenderer at the time of release of Supply / Purchase order
- 40. Deduction in payment -** If there is a shortfall in the quantity of supplied product/material, then the payment will be deducted thereof.
- 41.** TDS and GST will be deducted from the payment of successful tenderer as per government rules.

45. All the terms & conditions of this tender notice will be binding on the supplier / tenderer.

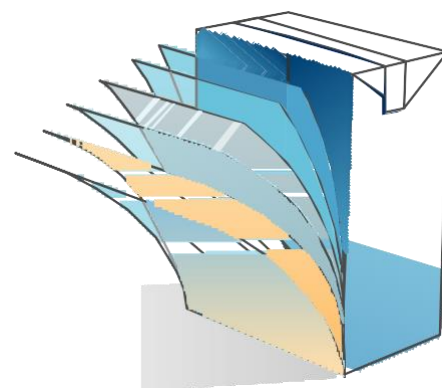

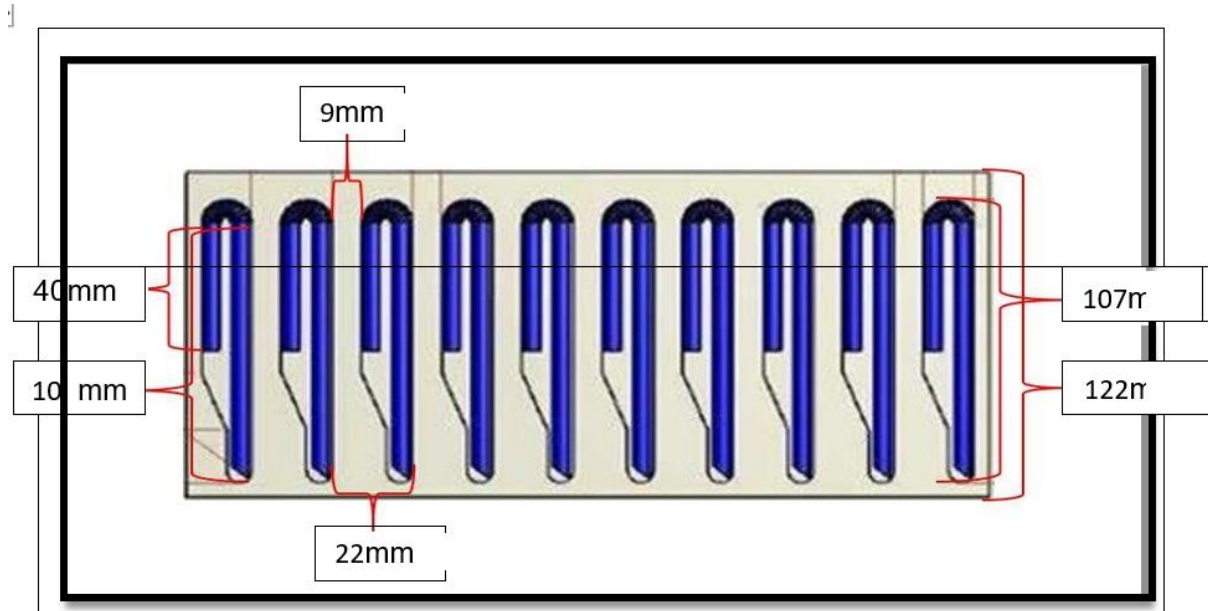
