- Online Tender on e-Procurement Portal https://cgmfpfedtenders.abcprocure.com as in Annexure – I (Technical Tender) and Annexure - II (Financial Tender) are invited from eligible tenderers for Supply, Installation, Testing and Hands-on Training of Primary Processing Machine for Kodo, Kutki and other MFPs as per specification given in Section 1 by Chhattisgarh State Minor Forest Produce (Trading & Development) Cooperative Federation Limited.

- 4. (i) Tenders are to be submitted only online in the prescribed Tender Forms only for Technical Tender (Annexure I) and Financial Tender (Annexure II).
 - (ii) The tenderer will propose in Financial Tender the **rate (inclusive of Basic Rate, G.S.T and Other Taxes if any should be mentioned)** F.O.R destination including all taxes i.e., Machines and Services Tax and surcharge and the Local Bodies Taxes if any on F.O.R destination basis. (Delivery locations (Destination) of the primary processing machine as mentioned in **clause 5** below is provided in **Annexure IV**.)

6. The Tenderer can quote for the tender according to his capacity to Install, Supply, Testing and Hands-on Training of Primary Processing Machines for Kodo, Kutki and other MFPs.

*Other MFPs shall mean Charota seeds, saal seeds, Chironji, mahua seeds, neem seeds, Harra, Baheda etc.

- The Tenderer shall submit online Technical and Financial Tender in separate Technical Tender Envelope and Financial Tender Envelope respectively mentioned in **Annexure** – V
- 8. The tenderer should upload certified photocopies of all the documents required in this tender notice. The tender for round 2 shall be accepted up to 15.00 hrs. on 14.12.2022 and Tender shall be opened online in this office only at 15.10 hrs. on 14.12.2022 even if it is a public holiday by the duly constituted Committee.
- 9. Decision of the Managing Director of the Federation to declare any of the tenderer to have or have not qualified in Technical Tender shall be final and binding on the tenderer. Intimation of decision of the competent authority shall be conveyed to the tenderers.
- 10. Financial Tender of only those tenderers who qualify in the pre-qualification shall be opened.
- 11. The financial evaluation of the bids submitted will be machine wise and the bid submitted shall be inclusive of all the equipment/machines as per specifications mentioned in Section 1. The Financial tender will be considered (L1) for total sum of all the Machines/ equipment specified in clause 5 of the tender notice for the specifications of required Machines/equipment as per Section 1 and the bidder quoting L1 will be awarded the work.
- 12. **Earnest Money Deposit (EMD):** The tenderer will have to make the online payment of EMD as shown in Clause 5 of the tender notice. EMD amount as shown in Clause 5 of the Tender notice will have to be deposited by the tenderer. The tender/s will summarily be rejected if there is any discrepancy in the amount of EMD that is required to be deposited as mentioned in clause 5 of the Tender Notice. EMD has to be deposited through payment gateway service provider in any of the following ways -

- A. Credit Card / Debit Card (VISA / Master / Maestro Cards) The tenderer after selecting the option of the Credit Card / Debit Card (VISA / Master / Maestro Cards) make the online payment, as per the instructions of payment mentioned in the payment gateway.
- B. **Net Banking** Tenderer can make the payment only from the bank account in having net banking facility. The list of banks for net banking will appear in the payment gateway and tenderer should select his bank from that list and make the payment as per the instructions given in the payment gateway.
- C. **RTGS / NEFT** The tenderer can make the payment as per the instructions of clause 2.2 of enclosed **Annexure V**.

The EMD of successful bidder shall be adjusted in the performance security. The E.M.D. of unsuccessful tenderers will be returned online only in the Bank Account mentioned in the point no. 12 of Form No. 1 **Annexure – I** only. No interest on E.M.D. will be paid in any circumstances.

- 13. The rate offered by the tenderer in the Financial Tender will be valid up to forty-five days from the date of opening of the Financial Tender but not later than 75 days of opening of the Technical Tender.
- 14. Rate should be clearly mentioned in the Financial Tender in figures only. The tenderer can tender for the Machine mentioned in clause 5 of this tender notice and pay the EMD accordingly.

15. Eligibility Criteria

A) Technical and Financial Capacity criteria

i. The tenderer should be Original Equipment Manufacturer (Submit firm registration certificate, or any other certificate issued by State/Central Government to establish that the bidder is an OEM.)

Or

The tenderer should be Authorised Dealer of Original Equipment Manufacturer (Submit MoU/agreement signed between the OEM & the authorized dealer)

ii. The Bidder should have supplied, installed and commissioned similar equipment (i.e., supply / installation of any type of Food processing Machine) for the Govt./PSU/Company/ Partnership Firm/Proprietorship/LLP etc. with minimum value of work of INR 30 lakh during the last three years in a single contract or multiple contracts.

Work/purchase order along with BOQ/Specification and proof of payment received (CA certificate etc.) from the client (Govt./PSU/Company/ Partnership Firm/Proprietorship/LLP etc.) certificate signed by CEO/Director/Vice President/General Manager of the company as the case may be. Satisfactory working certificate from the user/client to be submitted by the bidder)

iii. The minimum Average Annual Turnover shall be 50 Lakhs last three of the previous five financial years (i.e., 2017-18, 2018-19, 2019-20, 2020-21 and 2021-22). (Audited

balance sheet and Profit and loss account and annual turnover certificate duly signed by CA must be enclosed).

- iv. The tenderer must have latest GST/VAT/Sales Tax Clearance certificate along with copy of Registration certificate under Sales Tax.
- v. The tenderer must submit last three years income tax return
- vi. The tender from principal firm and authorized agent/dealer will not be accepted together.
- vii. The tenderer must submit the blacklisting certificate indicated that their firm is not blacklisted from any Government Organization.
- viii. As per section 139A of the Income Tax Act, 1961, enclosing of scanned copy of PAN card is compulsory for the tenderer.
- ix. Enclosing of Scanned copy of Aadhaar Card issued by Unique Identification Authority of India. (UIDAI) is compulsory. Scanned copy of Aadhaar Card of Managing Director of the Company and in case of Partnership firm Aadhaar Card of at least two of Partners required, in case of Hindu Undivided Family (HUF) Aadhaar Card of Karta and one adult family member is to be enclosed.
- 16. The CGMFP has the right to have a demonstration of the Machine/equipment in his premises. The supplier has to abide by this condition. The demonstration has to be arranged by the supplier at his own cost.
- 17. **Delivery of Machines** Within 45 days from the Date of issue of award letter or as specified in the supply order.

18. Person Authorised to Submit Tender

- i. Person or persons signing the tender form shall state in what capacity he or she or they are signing the tender form e.g., as sole proprietor of the firm concerned or as Managing Director or Director or Secretary of Limited Company. In the case of partnership firm, the names of all the partners should be recorded and the tender form should be signed by all the partners or their duly constituted attorney having authority to bind all partners in all matters pertaining to the contract as recorded in the power of attorney or in the partnership deed. True copy of the Registered "Partnership Deed" should be uploaded along with the tender form failing which the tender shall be liable to be rejected. It shall be obligatory on the part of every partner of the firm, which enters into agreement to fulfil the terms and conditions of the agreement during the currency of the contract thereof, notwithstanding the dissolution of the partnership in the meantime, In the case of a limited company, the tender form shall be signed by a person empowered to do so by the company, copy of Certificate of incorporation of the company and the letter authorizing the person signing the tender documents shall be uploaded to the tender form failing which the tender shall be liable to be rejected. In the case of Hindu undivided family, the names of the family members should be uploaded with the tender form and 'Karta' who can bind the family should sign the tender form.
- ii. The person signing the tender form on behalf of another or on behalf of a Firm shall enclose with the tender form power of attorney or deed duly executed in his favour or the partnership deed giving him such power showing that, he has the authority to bind such other person or the firm, as the case may be in all matters pertaining to the contract. If the person so signing the tender form fails to upload the said power of attorney or partnership deed, his tender shall be liable for summary rejection. The power of attorney should be signed by all the partners in the case of partnership concerns, by the proprietor in case of

a proprietary concern and by the person who by his signature can bind company in the case of limited company. In the case of Hindu undivided family, the power of attorney should be signed by the 'Karta' who by his signature can bind the family.

- 19. A bidder shall not have conflict of interest. All bidders found to have conflict of interest shall be disqualified. A bidder may be considered to be in conflict of interest with one or more parties in this bidding process, if, including but not limited to:
 - a) They have controlling shareholders in common or
 - b) They receive or have received direct or indirect subsidy from any of them or
 - c) They have the same legal representative for purposes of this bid or
 - d) They have a relationship with each other, directly or through common third parties,
 - e) that puts them in a position to have access to information about or influence on the bid of another bidder or
 - f) A bidder participates in more than one bid in this bidding process. Participation by a bidder in more than one bid will result in the disqualification of all bids in which the party is involved.
 - g) A bidder participated as a consultant in the preparation of the design or technical specification of the contract that is subject of the bid
- 20. The tenders submitted online should be signed electronically with a Digital Certificate to establish the identity of the tenderer tendering online. The tenderer can obtain the Digital Signature Certificate as per the instructions of step 1 of clause 1 of enclosed **Annexure V.**
- 21. In order to participate in the tender, the tenderer is required to get registered on the e-Procurement portal (https://cgmfpfedtenders.abcprocure.com). Only after online registration of the tenderer, the tenderer shall be allowed to participate in the tenders floated by the C.G.M.F.P Federation using the e-Procurement System. After obtaining the Digital Certificate as mentioned in above S.No. 20 and successfully installed on their system, the tenderer has to be online registered through "New Tenderer Registration" page of the e-Procurement portal (https://cgmfpfedtenders.abcprocure.com) and mapped their Digital Certificate.
- 22. The Instructions for submission of online tender (Annexure V) for tenderers to submit the online tenders will be available on e-Procurement portal https://cgmfpfedtenders.abcprocure.com and the online tender can be submitted as per time and date mentioned in time schedule (Annexure VI).
- 23. The tenderers will have to submit (Upload Scan Copies / fill) his / her offer / credentials online as required in the tender in the online templates in relevant envelopes.
- 24. The tenderers may refer User Manual for tenderers available online to perform their online activities. (Annexure V)
- 25. The Managing Director, Chhattisgarh State Minor Forest Produce (Trading & Development) Co-operative Federation Limited reserves the right to accept / reject any or all the tenders without specifying any reason thereof. He may relax any tender condition.
- 26. Conditional offer other than on our terms and conditions shall not be accepted.

- 27. SUPPLIERS WHO MAY NOT BE IN A POSITION TO MAKE TIMELY SUPPLIES OF QUALITY MACHINES ACCORDING TO TENDER SPECIFICATION AND GOOD FINISH SHOULD NOT TENDER.
- 28. Tenderers who are selected after opening of the financial tender have to supply the equipment/ machines within 45 days from the date of issue of sanction letter.
- 29. For the interpretation of the tender conditions, the decision of the Managing Director of Chhattisgarh State M.F.P Federation will be final. In case of any clarification, the tenderer may contact the Managing Director, Chhattisgarh State Minor Forest Produce (Trading & Development) Co-operative Federation Limited, Raipur.
- 30. All the terms & conditions of this tender notice will be binding on the supplier / tenderer.

- 3. All the stocks supplied shall be of best quality and conform to the specifications. The decision of the Managing Director, Chhattisgarh State Minor Forest Produce (T & D) Cooperative Federation Ltd. shall be binding upon the supplier and in case of any article supplied is not being approved, then expenses or loss caused to M.F.P. Federation as a result of rejection or replacement of supplies, shall be entirely to the account of the supplier.
- **4.** The Managing Director, Chhattisgarh State Minor Forest Produce (T & D) Co-operative Federation Ltd. or his duly authorized representative shall at all reasonable time access and examine the materials and workmanship of the machines.

25. Conflict of Interest:

- 26.1 The Agency is required to provide professional, objective and impartial advice and at all times hold the CGMFPFED's interest paramount, strictly avoid conflicts with other assignment/jobs or their own corporate interest and act without any consideration for future work.
- 26.2 Without limitation on the generality of the foregoing, Agency and any of their affiliates, shall be considered to have a conflict of interest under any of the circumstances set forth below:
- 26.3 Conflicting Assignment/job: An Agency (including its affiliates) shall not be hired for any assignment/job that, by nature, may be in conflict with another assignment/job of the Agency to be executed for the same or for another Employer.
- 26.4 Conflicting Relationships: An Agency that has a business or family relationship with a member of the CGMFPFED staff who is directly or indirectly involved in any part of the project shall not be awarded the Contract, unless the conflict stemming from this relationship has been resolved in a manner acceptable to the CGMFPFED throughout the selection process and the execution of the Contract.
- 26.5 Conflicting Activities: An Agency or any of its affiliates, selected to provide consulting assignment/job for this project shall be disqualified from subsequent downstream supply of goods or works or services resulting from or directly related to this project.
- 26.6 Agency have an obligation to disclose any situation of actual or potential conflict that impacts their capacity to serve the best interest of CGMFPFED, or that may reasonably be perceived as having this effect. Any such disclosure shall be made to CGMFPFED, immediately. If the Agency fails to disclose said situations and if the CGMFPFED comes to know about any such situation at any time, it may lead to the disqualification of the Agency during bidding process or the termination of its contract during execution of the assignment.

- 34.  - f. Any change in Address /Telephone/Fax/e-mail of the tenderer should immediately be informed. The state of non-communication by the firm will make the offer liable for rejection.

- **38.** The supplier shall insure that intimation of dispatch about the stock is sent to the concerned Managing Director District Union on the day of dispatch only by quick service available so that the consignee is in a position to make necessary arrangement for taking delivery of the stock at the centre/ location where the stock have to be delivered by the suppliers, as per the supply order. Copy of such intimation should also be dispatched to Chhattisgarh State Minor Forest Produce (T & D) Co-operative Federation Ltd., Raipur on the same day.
- **39.** All legal proceedings, if necessity arises to initiate by any of the parties Chhattisgarh State Minor Forest Produce (T & D) Co-operative Federation Ltd. or supplier shall have to be lodged in Courts situated in Raipur.
- **40.** Any dispute arising in connection with this agreement not amicably settled, would be referred to the arbitrator i.e., three-member Committee appointed by Chhattisgarh Govt. Raipur who will act as sole arbitrator and the verdict of the arbitrator shall be final and binding on both the parties.
- **41.** The Chhattisgarh State Minor Forest Produce (T & D) Co-operative Federation Ltd. shall have the right to accept or reject any or all tenders without assigning any reason thereof.
- **42.** Allocation of quantity / destinations to any tenderer shall be at the sole discretion of the Managing Director, Chhattisgarh State Minor Forest Produce (T & D) Co-operative Federation Ltd.
- **43.** Any condition other than those mentioned above, shall not be accepted.
- **44.** Any conditional offer shall be rejected summarily.
- **45.** The Managing Director, Chhattisgarh State Minor Forest Produce (T & D) Co-operative Federation Ltd. reserves the right to increase or decrease or cancel quantity mentioned in the tender notice or supply order at any time without assigning any reason at the risk and cost of the suppliers/tenderer.

Annexure – V

Instructions for the Submission of the Online Tender

(Ref: Clause 18 of Tender Notice)

Note: The following steps need to be carried out for online submission of the Tender. Detailed instructions for each of the steps are given in the Tenderer's Manual on the Home Page of https://cgmfpfedtenders.abcprocure.com

1. Sequence of steps for online tender submission:

Step 1 – To obtain Digital Signature Certificate (DSC):

The DSC is issued by an approved certifying authority, authorized by the Controller of Certifying Authorities (CCA), Government of India. The individual may obtain information required for issuance of a Class II / Class III DSC from the Controller of Certifying Authorities (www.cca.gov.in). The tenderer will have to obtain DSC from https://ccmmfpfedtenders.abcprocure.com or any other CCA approved agency.

DSC is issued upon receipt of mandatory identity proofs and verification letters attested by a Gazetted Officer. Only upon the receipt of the required documents, a DSC can be issued.

Important Note: The offers submitted online should be signed electronically with a DSC to establish the identity of the tenderer. In case, during the process of a particular tender, the user loses his/her DSC (e.g., due to virus attack, hardware problem, operating system problem etc.) he may not be able to submit the offer online. Hence the users are advised to back up the certificate and keep the copies at safe places under proper security to be used in case of emergencies.

In case of online tendering, the DSC issued to the authorized user of a firm and used for electronic tendering will be considered equivalent to no-objection certificate / power of attorney to that user.
